#### Q. What are my voting rights in the Homeowners' Association?

A. Each homeowner unit is entitled to one vote, which shall be cast by the respective unit owner. If more than one owner owns the unit, the total owners of such unit shall collectively be entitled to cast a vote attributed to that unit.

#### Q. What restrictions exist on my right to use my unit?

A. Completed application and \$100.00 application fee. One person in household must be 55 years of age or older.

# Q. How much are my assessments to the Homeowners' Association for my unit and when are they due?

- A. Monthly fees are \$190.00 per month payable to: Nature's Cove of Highland Lakes Homeowners' Association.
