FACILITY MAINTENANCE / CONTRACTED SERVICES

- Refuse collection occurs each Monday and Thursday by Solar Sanitation. Holiday collection will be delayed until the following normal collection day. The preferred disposal method is <u>black</u> plastic bags or 30 gallon plastic containers. Please put out refuse only on the day of collection due to crows and other scavengers. Small shrub and tree trimmings will be picked up if tied together in manageable lengths, ie; 4 foot maximum.
- Lawn mowing / edging services are provided and the frequency is adjusted to match the growing season requirement.
- Shrubbery trimming is performed on original plantings. In addition, the contractor trims only growth that can be reached from ground level. Residents should be prepared to self trim or hire help for some trimming requirements.
- Lawn fertilization and insect control is performed on a regular schedule. Application timing varies depending on the type being dispensed. A Board member can provide the details to those who are interested.
- Lawn irrigation is provided from an on-site well and irrigation system owned by the Camelot Village HOA and maintained by our contractor. Please familiarize yourself with sprinkler locations on your property and avoid them with vehicle and golf cart traffic. Sprinklers normally cycle each Tuesday and Friday on the west side from 12 midnight until 6 AM and the east side from 6 PM until midnight. Pinellas County establishes the days and frequency.
- Camelot Court is a private road owned and maintained by Camelot Village HOA.

ARCHITECTURAL STANDARDS SPECIFIC TO CAMELOT VILLAGE HOA

- Exterior work/revisions must be approved by the Camelot Village HOA Board and HLHOA ARC committee prior to beginning the work. See page # 14 for information regarding where to obtain an ARC application form.
- Driveway and entrance walkway material is restricted to uncolored troweled concrete or gray, vehicle compatible, flagstone pavers. The pavers cannot replace the existing concrete sidewalk or apron leading from the drive to Camelot Court road.
- Roofing shingles are restricted to Owens Corning dimensional style, asphalt material, color shasta white [see page # 8].
- Exterior paint colors applied in the year 2022 are described in the COLOR REFERENCE CHART [page # 8]. Any exterior paint application or door and window replacements must comply with these color specifications.
- Camelot Village ARC information is available online within the HLHOA Enumerate Engage, Camelot Village HOA Group listing and Monarch Association Management portal where other issues not addressed above can be reviewed in our governing documents item.
- NOTE: WINDOW REPLACEMENT IN CAMELOT VILLAGE HOA UNITS <u>REQUIRES PRIOR APPROVAL OF AN ARC APPLICATION.</u>
- NOTE THAT FLORIDA LAW HAS OBSOLETED THE CAMELOT VILLAGE HOA LANGUAGE REGARDING FLAG DISPLAYS.

MAILBOX AND YARD LIGHT STANDARDS

 The original designs have become difficult to acquire over the years resulting in some variations within Camelot Village HOA. In an effort to recreate a standard, please comply with the following pictorials when replacing your mailbox, mailbox post, yard light, and yard light post. IF A DEVIATION IS BEING CONSIDERED, AN ARC APPLICATION <u>MUST</u> BE SUBMITTED AND APPROVED BY THE CAMELOT VILLAGE BOARD. Note that the yard light post is 3" diameter while the mailbox post can be either 3" diameter or square configuration.





CAMELOT VILLAGE HOA WINDOW REPLACEMENT STANDARD

- <u>THIS STANDARD WILL BE EFFECTIVE BEGINNING 4/1/2024. ANY</u> EXISTING WINDOWS WILL BE " GRANDFATHERED " AND WILL NOT BE AFFECTED BY THIS STANDARD.
- ARC application requirement
 - Applications for replacement window installations that fit into the original opening must be approved by the Camelot Village HOA Board.
 - Applications for replacement window installations that require original window opening modifications must be accompanied by a Pinellas County Building Permit and be approved by the Camelot Village HOA Board and HLHOA ARC committee.
- Windows that face or are oblique to Camelot Court Road
 - Window design is restricted to double or single hung construction that includes 6x6 lattice trim.
 - Screening to be black color.
 - Frame to conform to the Camelot Village HOA trim color specification.
 - Glass to be clear color with slight manufacturer tint expected.
- All other windows
 - Window design can match other windows, be picture window design, or be slideby design except bedroom windows must provide emergency egress.
 - Screening to be black color.
 - Frame to conform to the Camelot Village HOA trim color specification.
 - Glass to be clear color with slight manufacturer tint expected.

RENTAL APPLICATION

 Rental of Camelot Village HOA units is governed by language contained in the HLHOA Policies, Rules, and Procedure Manual titled RESIDENTS ENTITLED TO USE and RESIDENT ACCESS pages # 306 and 307. Because this procedure requires the unit owner to surrender their amenity-use privileges, the application and reissue is controlled by the HLHOA administration. Therefore, an owner who desires to rent their unit is required to obtain the application from the HLHOA desk and personally process its' approval through the Camelot Village HOA Board and HLHOA administration.
